


The market closed in red today. The benchmark index DSEX (-1.00%) lost 70.52 points and closed at 7,005.71. The blue-chip index DS30 (-0.04%), the Shariah-based index DSES (-2.00%), and the large-cap index CDSET (+0.11%) closed at 2,698.31, 1,487.79, and 1,442.99 points, respectively. All the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 1.73% followed by Telecommunication (-1.48%), Pharmaceutical (-1.47%), Engineering (-1.03%), Food & Allied (-0.90%), Bank (-0.59%), and Fuel & Power (-0.03%), respectively. Block trades contributed 0.2% of the overall market turnover. Bangladesh Export Import Company Ltd. (+7.5%) was the most traded share with a turnover of BDT 3,422 million.


