


Indox

Closing

The market closed in red today. The benchmark index DSEX (-0.09%) lost 5.92 points and closed at 6,878.76. The blue-chip index DS30 (-0.16%), the Shariah-based index DSES (-0.09%), and the large-cap index CDSET (-0.16%) closed at 2,459.70, 1,493.21, and 1,340.38 points, respectively. Large-cap sectors posted mixed performance today. NBFI booked the highest gain of 2.51% followed by Telecommunication (+0.63%), Food & Allied (+0.08%). Engineering experienced the highest loss of 0.2% followed by Fuel & Power (-0.09%), Bank (-0.08%), Pharmaceutical (-0.08%). Block trades contributed 2.2% of the overall market turnover. Bangladesh Export Import Company Ltd. (-0.2%) was the most traded share with a turnover of BDT 873 million.



# Important DSE News

#### DHAKABANK

(Q2 Un-audited): Consolidated EPS was Tk. 0.47 for April-June 2021 as against Tk. 0.18 for April-June 2020; Consolidated EPS was Tk. 1.10 for January-June 2021 as against Tk. 0.79 for January-June 2020. Consolidated NOCFPS was Tk. 3.98 for January-June 2021 as against Tk. (5.81) for January-June 2020. Consolidated NAV per share was Tk. 20.97 as on June 30, 2021 and Tk. 19.60 as on June 30, 2020. The Company has informed that EPS increased due to increase of total Operating Income by Tk. 71.83 crore (Tk. 289.81 crore in Q2 of 2021, whereas Tk. 217.97 crore was in Q2 of 2020).
