
BRAC EPL STOCK BROKERAGE LTD **Daily Market Update**

The market closed in red today. The benchmark index DSEX (-1.72%) lost 120.41 points and closed at 6,885.29. The bluechip index DS30 (-1.99%), the Shariah-based index DSES (-1.49%), and the large-cap index CDSET (-2.10%) closed at 2,644.55, 1,465.60, and 1,412.75 points, respectively. All the large-cap sectors posted negative performance today. Food & Allied experienced the highest loss of 2.84% followed by NBFI (-2.42%), Fuel & Power (-2.16%), Engineering (-1.63%), Pharmaceutical (-1.26%), Telecommunication (-0.82%), and Bank (-0.51%), respectively. Block trades contributed 0.3% of the overall market turnover. Delta Life Insurance Company Ltd. (+3.9%) was the most traded share with a turnover of BDT 1,556 million.


