

The market closed in green today. The benchmark index DSEX (+1.75%) gained 120.49 points and closed at 7,005.78. The blue-chip index DS30 (+0.65%), the Shariah-based index DSES (+1.15%), and the large-cap index CDSET (+0.51%) closed at 2,661.65, 1,482.46, and 1,419.96 points. respectively. All the large-cap sectors posted positive performance today. NBFI booked the highest gain of 4.15% followed by Fuel & Power (+1.64%), Engineering (+1.60%), Food & Allied (+1.56%), Pharmaceutical (+0.63%), Bank (+0.42%), and Telecommunication (-0.46%), respectively. Block trades contributed 0.6% of the overall market turnover. Bangladesh Export Import Company Ltd. (+1.1%) was the most traded share with a turnover of BDT 868 million.


