
DSEX Index Closing 7,237.14 \(\tag{-13.46}, \text{-0.19%} \)

Market closed in red

The market closed in red today. The benchmark index DSEX (-0.19%) lost 13.46 points and closed at 7,237.14. The blue-chip index DS30 (-0.30%), the Shariah-based index DSES (-0.41%), and the large-cap index CDSET (-0.30%) closed at 2,665.61, 1,574.59, and 1,435.02 points, respectively. All the large-cap sectors posted negative performance today. Engineering experienced the highest loss of 0.80% followed by Bank (-0.68%), Food & Allied (-0.40%), Pharmaceutical (-0.35%), Telecommunication (-0.17%), Fuel & Power (-0.17%), and NBFI (+0.12%), respectively. Block trades contributed 5.8% of the overall market turnover. Orion Pharma Ltd. (+8.8%) was the most traded share with a turnover of BDT 1,421 million.





Figure: Sectorial Mcap Change
