

Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.57%) gained 33.92 points and closed at 6,026.65. The blue-chip index DS30 (+0.37%), the Shariahbased index DSES (+0.57%), and the large-cap index CDSET (+0.38%) closed at 2,176.64, 1,294.81, and 1,215.22 points, respectively. All the large-cap sectors $\underset{\square}{\times}$ posted positive performance today. NBFI booked the highest gain of 1.45% followed by Engineering (+0.78%), Pharmaceutical (+0.52%), Fuel & Power (+0.44%), Food & Allied (+0.37%), Telecommunication (+0.15%), and Bank (+0.09%), respectively. Block trades contributed 7.9% of the overall market turnover. Delta Life Insurance Company Ltd. (+10.0%) was the most traded share with a turnover of BDT 1,366 million.



Refer to their earlier news disseminated by DSE on 30.12.2020 regarding Decision to issue Mudaraba Perpetual Bond, the Company has further informed that Board of Directors has decided to raise BDT 500.00 crore through issuance of AIBL Mudaraba Perpetual Bond for inclusion in addition Tire- 1 Capital of the Bank under Basel- III norms complying with Bangladesh Bank Guidelines on Risk Based Capital Adequacy, on private placement basis for BDT 450.00 crore and the rest amount of BDT 50.00 crore on public offer basis instead of private placement basis for entire amount of BDT 500.00 crore in the line with Directive issued by Bangladesh Securities and Exchange Commission, other regulatory requirements and subject to approval from concerned regulatory authorities as well as approval of the shareholders of the Company.

BEACHHATCH

The Company has informed that the Board of Directors has decided to start production activities of the company from the date 28.06.2021 of white fish (Telapia, Koi, Pangsh and Pabda) using Intensive Culture Method. Initially, the production capacity will be around 105T per Year, using 15 Nos. concrete tanks, each with water holding capacity of 55,000 litres. The production process will constitute hatchery unit, nursery unit, pre-growout, growout, harvesting and sale. The production capacity will be gradually increased organically, using existing, un-utilized structures.
