


## Market closed in red

The market closed in red today. The benchmark index DSEX (-1.14%) lost 78.19 points and closed at 6,773.90. The blue-chip index DS30 (-1.03%), the Shariah-based index DSES (-0.91%), and the large-cap index CDSET (-1.26%) closed at 2,576.17, 1,429.33, and 1,381.66 points, respectively. All the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 1.91% followed by Fuel & Power (-1.07%), Bank (-0.86%), Pharmaceutical (-0.75%), Engineering (-0.52%), Food & Allied (-0.22%), and Telecommunication (-0.12%), respectively. Block trades contributed 1.3% of the overall market turnover. Bangladesh Export Import Company Ltd. (-4.1%) was the most traded share with a turnover of BDT 917 million.


