


Market closed in green

The market closed in green today. The benchmark index DSEX (+0.72%) gained 50.47 points and closed at 7,062.36. The blue-chip index DS30 (-0.20%), the Shariah-based index DSES (-0.14%), and the large-cap index CDSET (-0.09%) closed at 2,638.91, 1,479.39, and 1,414.75 points, respectively. Large-cap sectors posted mixed performance today. Bank booked the highest gain of 1.74% followed by NBFI (+1.20%), Telecommunication (+0.27%). Food & Allied experienced the highest loss of 2.47% followed by Fuel & Power (-2.22%), Engineering (-0.79%), Pharmaceutical (-0.57%). Block trades contributed 0.4% of the overall market turnover. Bangladesh Export Import Company Ltd. (+2.1%) was the most traded share with a turnover of BDT 1,744 million.


