
Market closed in green

Daily Market Update

The market closed in green today. The benchmark index DSEX (+1.79%) gained 107.99 points and closed at 6,150.48. The blue-chip index DS30 (+1.03%), the Shariahbased index DSES (+1.26%), and the large-cap index CDSET (+1.20%) closed at 2,208.38, 1,314.76, and 1,234.81 points, respectively. All the large-cap sectors posted positive performance today. NBFI booked the highest gain of 2.50% followed by Bank (+1.96%), Fuel & Power (+1.37%),Engineering (+1.09%).Telecommunication (+1.05%), Food & Allied (+0.95%), and Pharmaceutical (+0.83%), respectively. Block trades contributed 5.1% of the overall market turnover. Square Pharmaceuticals Ltd. (+0.8%) was the most traded share with a turnover of BDT 875 million.





Figure: Sectorial Mcap Change
