

Market closed in red



Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.87%) lost 61.41 points and closed at 7.000.95. The blue-chip index DS30 (-0.69%), the Shariah-based index DSES (-0.60%), and the large-cap index CDSET (-0.63%) closed at 2,620.60, 1,470.50, and 1,405.77 points, respectively. All the large-cap sectors posted negative performance today. Food & Allied experienced the highest loss of 1.53% followed by Fuel & Power (-1.45%), Engineering (-1.21%), Bank (-1.09%), NBFI (-Pharmaceutical 0.92%). (+0.30%).Telecommunication (+1.05%), respectively. Block trades contributed 0.4% of the overall market turnover.
