


The market closed in green today. The benchmark index DSEX (+0.84%) gained 54.3 points and closed at 6,535.87. The blue-chip index DS30 (+0.95%), the Shariahbased index DSES (+0.88%), and the large-cap index CDSET (+0.87%) closed at 2,366.45, 1,424.61, and 1,279.89 points, respectively. All the large-cap sectors posted positive performance today. Bank booked the highest gain of 2.02% followed by Engineering (+1.86%), NBFI (+1.01%), Fuel & Power (+0.84%), Pharmaceutical (+0.73%), Telecommunication (-0.21%), and Food & Allied (-0.21%), respectively. Block trades contributed 1.3% of the overall market turnover. Bangladesh Export Import Company Ltd. (+2.4%) was the most traded share with a turnover of BDT 1,095 million.




Figure: Sectorial Mcap Change
