
## Market closed in red

The market closed in red today. The benchmark index DSEX (-1.37%) lost 96.85 points and closed at 6,952.14. The blue-chip index DS30 (-1.48%), the Shariah-based index DSES (-0.88%), and the large-cap index CDSET (-1.48%) closed at 2,621.05, 1,467.07, and 1,406.67 points, respectively. All the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 2.60% followed by Bank (-1.71%), Fuel & Power (-1.07%), Engineering (-0.95%), Pharmaceutical (-0.78%), Food & Allied (-0.45%), and Telecommunication (-0.42%), respectively. Block trades contributed 0.4% of the overall market turnover. Bangladesh Export Import Company Ltd. (-4.3%) was the most traded share with a turnover of BDT 964 million.




