


Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.21%) lost 10.87 points and closed at 5,185.83. The blue-chip index DS30 (-0.30%), the Shariah-based index DSES (+0.10%), and the large-cap index CDSET (-0.25%) closed at 1,924.89, 1,167.11, and 1,046.28 points, respectively. Largecap sectors posted mixed performance today. Fuel & Power booked the highest gain of 0.84%, followed by Food & Allied (+0.09%), Engineering (+0.02%), Pharmaceutical (-0.20%), Bank (-0.60%), Telecommunication (-0.65%), and NBFI (-0.77%), respectively. Block trades contributed 4.0% of the overall market turnover. Beximco Pharmaceuticals Ltd. (+1.4%) was the most traded share with a turnover of BDT 240 million.


