Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.17%) gained 10.3 points and closed at 6,215.18. The blue-chip index DS30 (+0.13%), the Shariah-based index DSES (+0.15%), and the large-cap index CDSET (+0.10%) closed at 2,201.93, 1,347.52, and 1,209.70 points, respectively. Most of the large-cap sectors posted positive performance today. Food & Allied booked the highest gain of 0.35% followed by Fuel & Power (+0.14%), Pharmaceutical (+0.13%),Bank (+0.09%), Engineering Telecommunication (0.00%), and NBFI (-0.01%), respectively. Block trades contributed 6.9% of the overall market turnover. aamra networks limited (-0.8%) was the most traded share with a turnover of BDT 309 million.




