

Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.73%) lost 41.26 points and closed at 5,633.61. The blue-chip index DS30 (-0.18%), the Shariah-based index DSES (-0.59%), and the large-cap index CDSET (-0.39%) closed at 1,980.43, 1,235.73, and 1,070.37 points, respectively. All the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 2.07% followed by Food & Allied (-0.92%), Fuel & Power (-0.49%), Engineering (-0.39%), Bank (-0.34%), Telecommunication (-0.29%), and Pharmaceutical (-0.15%), respectively. Block trades contributed 4.2% of the overall market turnover. Asiatic Laboratories Limited (+6.1%) was the most traded share with a turnover of BDT 399 million.




