Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.12%) gained 7.71 points and closed at 6,274.06. The bluechip index DS30 (-0.21%), the Shariah-based index DSES (+0.23%), and the large-cap index CDSET (+0.10%) closed at 2,208.57, 1,362.90, and 1,212.34 points, respectively. Largecap sectors posted mixed performance today. Fuel & Power booked the highest gain of 0.25% followed by NBFI (+0.20%), Bank (+0.18%), Pharmaceutical (+0.12%). Food & Allied experienced the highest loss of 0.16% followed by Engineering (-0.02%), Telecommunication (0.00%). Block contributed 15.8% of the overall market turnover. Genex Infosys Limited (+1.6%) was the most traded share with a turnover of BDT 451 million.




