

## **Daily Market Update**

The market closed in green today. The benchmark index DSEX (+0.66%) gained 37.68 points and closed at 5,776.08. The blue-chip index DS30 (+0.62%), the Shariah-based index DSES (+0.95%), and the large-cap index CDSET (+0.42%) closed at 2,014.14, 1,257.16, and 1,095.68 points, respectively. All the large-cap sectors posted positive performance today. NBFI booked the highest gain of 1.81% followed by Engineering (+1.04%), Pharmaceutical (+0.99%), Telecommunication (+0.74%), Fuel & Power (+0.56%), Food & Allied (+0.09%), and Bank (-0.33%), respectively. Block trades contributed 8.4% of the overall market turnover. Malek Spinning Mills Ltd. (+4.6%) was the most traded share with a turnover of BDT 280 million.


