

Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.35%) gained 20.05 points and closed at 5,796.12. The blue-chip index DS30 (+0.04%), the Shariah-based index DSES (+0.74%), and the large-cap index CDSET (+0.28%) closed at 2,014.93, 1,266.41, and 1,098.73 points, respectively. Most of the large-cap sectors posted positive performance today. NBFI booked the highest gain of 1.34% × 5,500 followed by Pharmaceutical (+0.64%), Fuel & Power (+0.14%), Food & Allied (+0.06%), Telecommunication (+0.03%), Bank (-0.15%), and Engineering (-0.22%), respectively. Block trades contributed 12.4% of the overall market turnover. Malek Spinning Mills Ltd. (-1.0%) was the most traded share with a turnover of BDT 203 million.


