


Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.55%) gained 34.02 points and closed at 6,254.83. The bluechip index DS30 (+0.62%), the Shariah-based index DSES (+0.55%), and the large-cap index CDSET (+0.22%) closed at 2,121.67, 1,358.10, and 1,208.43 points, respectively. All the large-cap sectors posted positive performance today. Pharmaceutical booked the highest gain of 0.48% followed by Food & Allied (+0.30%), Engineering (+0.27%), Bank (+0.20%), Fuel & Power (+0.20%), NBFI (+0.04%), and Telecommunication (0.00%), respectively. Block trades contributed 9.4% of the overall market turnover. Fu Wang Food Ltd. (+9.4%) was the most traded share with a turnover of BDT 276 million.


