


The market closed in green today. The benchmark index DSEX (+0.25%) gained 15.69 points and closed at 6,315.83. The bluechip index DS30 (+0.80%), the Shariah-based index DSES (+0.55%), and the large-cap index CDSET (+0.54%) closed at 2,265.36, 1,387.67, and 1,244.51 points, respectively. Large-cap sectors posted mixed performance today. Pharmaceutical booked the highest gain of 1.09% followed by NBFI (+0.43%), Telecommunication (+0.10%), Food & Allied (+0.04%). Fuel & Power experienced the highest loss of 0.59% followed by Engineering (-0.38%), Bank (-0.10%). Block trades contributed 0.6% of the overall market turnover. Bangladesh Export Import Company Ltd. (+0.6%) was the most traded share with a turnover of BDT 1,083 million.


