

Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.29%) gained 18.14 points and closed at 6,298.23. The bluechip index DS30 (+0.45%), the Shariah-based index DSES (+0.39%), and the large-cap index CDSET (+0.01%) closed at 2,140.17, 1,371.01, and 1,212.59 points, respectively. All the large-cap sectors posted positive performance today. Pharmaceutical booked the highest gain of 0.17% followed by Food & Allied (+0.14%), Bank (+0.11%), Engineering (+0.07%), Fuel & Power (+0.04%), Telecommunication (+0.00%), and NBFI (0.00%), respectively. Block trades contributed 10.1% of the overall market turnover. Fu Wang Food Ltd. (+9.7%) was the most traded share with a turnover of BDT 319 million.


