The market closed in red today. The benchmark index DSEX (-0.02%) lost 1.27 points and closed at 6,251.29. The blue-chip index DS30 (-0.13%), the Shariah-based index DSES (-0.02%), and the large-cap index CDSET (-0.06%) closed at 2,112.47, 1,360.44, and 1,206.96 points, respectively. Largecap sectors posted mixed performance today. Pharmaceutical booked the highest gain of 0.08%, followed by Fuel & Power (+0.04%), Bank (+0.01%), Telecommunication (+0.00%), NBFI (-0.01%), Engineering (-0.02%), and Food & Allied (-0.13%), respectively. Block trades contributed 6.6% of the overall market turnover. Central Pharmaceuticals Limited (+10.0%) was the most traded share with a turnover of BDT 334 million.


