Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.06%) lost 3.94 points and closed at 6,256.83. The blue-chip index DS30 (-0.02%), the Shariah-based index DSES (+0.04%), and the large-cap index CDSET (-0.02%) closed at 2.208.48, 1,372.96, and 1,220.35 points, respectively. Largecap sectors posted mixed performance today. Food & Allied booked the highest gain of 0.10% followed by Bank (+0.02%), Engineering (+0.01%). Pharmaceutical experienced the highest loss of 0.23% followed by Fuel & Power (-0.07%), NBFI (-0.03%). Block trades contributed 4.0% of the overall market turnover. Salvo Chemical Industry Limited (-6.2%) was the most traded share with a turnover of BDT 341 million.




