Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.18%) lost 11.21 points and closed at 6,245.61. The blue-chip index DS30 (-0.20%), the Shariah-based index DSES (-0.29%), and the large-cap index CDSET (-0.15%) closed at 2,204.14, 1,368.95, and 1,218.52 points, respectively. Most of the large-cap sectors posted negative performance today. Pharmaceutical experienced the highest loss of 0.52% followed by Bank (-0.04%), Food & Allied (-0.03%), NBFI (-0.01%), Fuel & Power (0.00%), Telecommunication (0.00%), and Engineering (+0.06%), respectively. Block trades contributed 4.2% of the overall market turnover. Intraco Refueling Station Limited (-0.4%) was the most traded share with a turnover of BDT 230 million.




