


Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.16%) gained 9.86 points and closed at 6,261.03. The blue-chip index DS30 (+0.08%), the Shariah-based index DSES (+0.29%), and the large-cap index CDSET (-0.01%) closed at 2,099.21, 1,366.71, and 1,205.81 points, respectively. Large-cap sectors posted mixed performance today. Food & Allied booked the highest gain of 0.31%, followed by Pharmaceutical (+0.23%), Engineering (+0.05%), Telecommunication (+0.00%), Fuel & Power (-0.02%), NBFI (-0.04%), and Bank (-0.06%), respectively. Block trades contributed 6.8% of the overall market turnover. Orion Infusion Ltd. (+8.7%) was the most traded share with a turnover of BDT 277 million.




