
DSEX Index Closing 5,074.59 \(\tag{-33.45}, -0.65\% \)

Market closed in red

The market closed in red today. The benchmark index DSEX (-0.65%) lost 33.45 points and closed at 5,074.59. The blue-chip index DS30 (-0.25%), the Shariah-based index DSES (-0.82%), and the large-cap index CDSET (-0.58%) closed at 1,794.14, 1,170.41, and 1,040.73 points, respectively. All the large-cap sectors posted negative performance today except Engineering (+2.71%). Food & Allied experienced the highest loss of 2.18% followed by NBFI (-2.14%), Telecommunication (-1.71%), Bank (-1.34%), Fuel & Power (-0.96%) and Pharmaceutical (-0.63%), respectively. Block trades contributed 6.7% of the overall market turnover. Bangladesh Export Import Company Ltd. (+8.4%) was the most traded share with a turnover of BDT 685 million.


