
Market closed in green



# **Daily Market Update**

The market closed in green today. The benchmark index DSEX (+0.30%) gained 15.74 points and closed at 5,344.01. The blue-chip index DS30 (+0.45%), the Shariah-based index DSES (+0.40%), and the large-cap index CDSET (+0.45%) closed at 1,924.26, 1,231.65, and 1,107.30 points, respectively. All the large-cap sectors posted positive performance today except Fuel & Power (-1.46%). Telecommunication booked the highest gain of 2.54% followed by NBFI (+1.46%), Engineering (+1.08%), Food & Allied (+0.56%), Pharmaceutical (+0.53%) and Bank (-0.04%), respectively. Block trades contributed 2.8% of the overall market turnover. Bangladesh Export Import Company Ltd. (+7.0%) was the most traded share with a turnover of BDT 1,301 million.




