# **Daily Market Update**

The market closed in green today. The benchmark index DSEX (+0.18%) gained 11 points and closed at 6,206.81. The blue-chip index DS30 (+0.05%), the Shariah-based index DSES (+0.23%), and the large-cap index CDSET (+0.03%) closed at 2,195.30, 1,358.84, and 1,214.42 points, respectively. Most of the large-cap sectors posted positive performance today. Pharmaceutical booked the highest gain of 0.39% followed by Food & Allied (+0.13%), Engineering (+0.09%), Bank (+0.06%), Fuel & Power (+0.01%), Telecommunication (0.00%), and NBFI (-0.01%), respectively. Block trades contributed 6.3% of the overall market turnover. Intraco Refueling Station Limited (+2.0%) was the most traded share with a turnover of BDT 172 million.




