## **Daily Market Update**

The market closed in green today. The benchmark index DSEX (+0.81%) gained 39.98 points and closed at 4,974.84. The blue-chip index DS30 (+1.30%), the Shariah-based index DSES (+0.79%), and the large-cap index CDSET (+0.82%) closed at 1,727.13, 1,135.54, and 1,009.20 points, respectively. All the large-cap sectors posted positive performance today. NBFI booked the highest gain of 1.49% followed by Pharmaceutical (+1.31%), Food & Allied (+1.21%), Engineering (+0.96%), Fuel & Power (+0.50%), Telecommunication (+0.43%), and Bank (+0.26%), respectively. Block trades contributed 4.4% of the overall market turnover. Bangladesh Export Import Company Ltd. (+3.1%) was the most traded share with a turnover of BDT 427 million.




