Daily Market Update

The market closed in green today. The benchmark index DSEX (+1.16%) gained 73.72 points and closed at 6,447.07. The blue-chip index DS30 (+1.01%), the Shariah-based index DSES (+0.77%), and the large-cap index CDSET (+1.39%) closed at 2,159.92, 1,398.06, and 1,216.89 points, respectively. Large-cap sectors posted mixed performance today. Bank booked the highest gain of 4.29%, followed by NBFI (+3.92%), Pharmaceutical (+0.31%), Telecommunication (+0.03%), Food & Allied (-0.00%), Fuel & Power (-0.42%), and Engineering (-1.45%), respectively. Block trades contributed 2.0% of the overall market turnover. Fortune Shoes Limited (+9.0%) was the most traded share with a turnover of BDT 651 million.




