


# **Daily Market Update**

The market closed in red today. The benchmark index DSEX (-0.39%) lost 24.25 points and closed at 6,258.98. The blue-chip index DS30 (+0.09%), the Shariah-based index DSES (-0.55%), and the large-cap index CDSET (-0.19%) closed at 2,131.28, 1,361.32, and 1,187.85 points, respectively. Most of the large-cap sectors posted negative performance today. Engineering experienced the highest loss of 1.64% followed by Telecommunication (-1.21%), Pharmaceutical (-0.40%), Fuel & Power (-0.38%), Food & Allied (-0.18%), Bank (+0.06%), and NBFI (+0.31%), respectively. Block trades contributed 3.4% of the overall market turnover. Orion Infusion Ltd. (-4.0%) was the most traded share with a turnover of BDT 419 million.

#### **Figure: Sectorial Mcap Change**




Figure: Sectorial Turnover (BDT Mn)
