## **Daily Market Update**

The market closed in green today. The benchmark index DSEX (+0.28%) gained 17.83 points and closed at 6,273.96. The blue-chip index DS30 (+0.35%), the Shariah-based index DSES (+0.06%), and the large-cap index CDSET (-0.02%) closed at 2,139.58, 1,360.52, and 1,185.75 points, respectively. Large-cap sectors posted mixed performance today. Bank booked the highest gain of 0.75%, followed by Engineering (+0.37%), Food & Allied (+0.03%), Pharmaceutical (-0.08%), Telecommunication (-0.10%), Fuel & Power (-0.47%), and NBFI (-0.80%), respectively. Block trades contributed 3.9% of the overall market turnover. Uttara Bank Limited (+8.4%) was the most traded share with a turnover of BDT 349 million.




