

BRAC EPL STOCK BROKERAGE LTD **Daily Market Update**

The market closed in green today. The benchmark index DSEX (+1.18%) gained 65.8 points and closed at 5.647.67. The blue-chip index DS30 (+1.74%), the Shariahbased index DSES (+0.86%), and the large-cap index CDSET (+1.39%) closed at 2,173.74, 1,261.30, and 1,211.17 points, respectively. Large-cap sectors posted mixed performance today. Food & Allied booked the $\frac{100}{100}$ highest gain of 5.27% followed by Bank (+1.22%), Pharmaceutical (+1.10%), NBFI (+0.75%). Engineering experienced the highest loss of 1.78% followed by Fuel & Power (-0.14%), Telecommunication (-0.07%). Block trades contributed 3.6% of the overall market turnover. Bangladesh Export Import Company Ltd. (+1.3%) was the most traded share with a turnover of BDT 852 million.


