


Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.09%) lost 5.81 points and closed at 6,280.72. The blue-chip index DS30 (+0.11%), the Shariah-based index DSES (+0.06%), and the large-cap index CDSET (+0.01%) closed at 2,228.80, 1,369.01, and 1,222.84 points, respectively. Most of the large-cap sectors posted negative performance today. Fuel & Power experienced the highest loss of 0.16% followed by Engineering (-0.07%), Food & Allied (-0.06%), Bank (-0.06%), Telecommunication NBFI (-0.01%),(0.00%),and Pharmaceutical (+0.13%), respectively. Block trades contributed 13.1% of the overall market turnover. Bangladesh Shipping Corporation (+2.4%) was the most traded share with a turnover of BDT 552 million.



Important DSE News OIMEX

The Board of Directors has recommended 1% cash dividend to general shareholders other than Sponsors and Directors for the year ended June 30, 2022. The Sponsors and Directors hold 20,133,184 shares out of total 67,084,781 shares of the Company. General shareholders hold 46,951,597 shares and general shareholders will get cash dividend of Tk. 4,695,159.70. Date of AGM: 30.03.2023, Time: 2:00 PM, Venue: Digital Platform. Record Date: 27.02.2023. The Company has also reported EPS of Tk. (1.65), NAV per share of Tk. 11.72 and NOCFPS of Tk. (0.57) for the year ended June 30, 2022 as against Tk. 0.08, Tk. 13.38 and Tk. 0.88 respectively for the same period of the previous year.

UPGDCL

(Q2 Un-audited): Consolidated EPS was Tk. 4.84 for October-December 2022 as against Tk. 6.85 for October-December 2021; Consolidated EPS was Tk. 9.85 for July-December 2022 as against Tk. 11.84 for July-December 2021. Consolidated NOCFPS was Tk. 9.59 for July-December 2022 as against Tk. (9.22) for July-December 2021. Consolidated NAV per share was Tk. 49.23 as on December 31, 2022 and Tk. 56.38 as on June 30, 2022.

TOSRIFA

Naim Hassan, one of the Sponsor Directors of the company, has expressed his intention to buy 3,71,288 shares of the company at prevailing market price (in the Block Market) through Dhaka Stock Exchange within next 30 working days as per Rule-4 of the BSEC (Substantial Acquisition of Shares and Takeovers), Rules, 2018.

BARKAPOWER

Abdul Bari, one of the Directors of the Company, has expressed his intention to sell 47,14,138 shares (in the Block Market) whereas NRB Ventures (Pvt.) Limited and Fusion Holdings (Pvt) Limited, both the Corporate Directors of the company, have expressed their intention to buy 20,45,579 shares and 26,68,559 shares respectively at prevailing market price (in the Block Market) through Dhaka Stock Exchange within next 30 working days.

SHEPHERD

The Company will be placed in 'A' category from existing 'B' category with effect from February 7, 2023 as the Company has reported disbursement of 10% cash dividend for the year ended June 30, 2022.

BDTHAIFOOD

The Company will be placed in 'B' category from existing 'N' category with effect from February 7, 2023 as the Company has reported disbursement of 3% cash dividend for the year ended June 30, 2022.

UPGDCL

The Company has informed that the Company which was formerly known as Malancha Holdings Ltd. entered into Power Supply Agreement (the PSA) dated 06 May 2007 and 16 May 2007 with Bangladesh Export Processing Zones Authority (BEPZA) for installation of commercial power plant in Dhaka EPZ and Chattogram EPZ respectively. The captive power plant rate has been changed recently and increased in such an extent that the selling price of electricity is lower than the raw material price going against the construction, generation, distribution, operation and maintenance of power industry. Under the above circumstances, pursuant to Clause 11(IV) of the Power Supply Agreement the Company has given notice to BEPZA dated 25 January, 2023 declaring the change as a Force Majeure event and for such reason notice for closing down the operation of power plants within Dhaka EPZ and Chattogram EPZ.
