


## **Daily Market Update**

The market closed in green today. The benchmark index DSEX (+0.07%) gained 4.69 points and closed at 6,285.40. The blue-chip index DS30 (+0.26%), the Shariah-based index DSES (+0.06%), and the large-cap index CDSET (+0.11%) closed at 2,234.68, 1,369.86, and 1,224.21 points, respectively. Large-cap sectors posted mixed performance today. Food & Allied booked the highest gain of 0.35% followed by Pharmaceutical (+0.09%), Telecommunication (0.00%). Bank experienced the highest loss of 0.11% followed by Fuel & Power (-0.10%), Engineering (-0.05%), NBFI (-0.04%). Block trades contributed 11.4% of the overall market turnover. Genex Infosys Limited (+3.1%) was the most traded share with a turnover of BDT 567 million.




