

The market closed in red today. The benchmark index DSEX (-2.33%) lost 128.32 points and closed at 5.376.46. The blue-chip index DS30 (-3.23%), the Shariah-based index DSES (-1.68%), and the large-cap index CDSET (-2.91%) closed at 2,023.47, 1,214.74, and 1,136.51 points, respectively. All the large-cap sectors posted negative performance today. Food & Allied experienced the highest of 5.28% followed by NBFI (-4.17%),loss Telecommunication (-3.22%), Engineering (-2.88%), Bank (-1.56%), Fuel & Power (-1.38%), and Pharmaceutical (-1.32%), respectively. Block trades contributed 2.0% of the overall market turnover. Bangladesh Export Import Company Ltd. (-7.6%) was the most traded share with a turnover of BDT 1,400 million.


