
Market closed in green

The market closed in green today. The benchmark index DSEX (+2.27%) gained 122.08 points and closed at 5,498.54. The blue-chip index DS30 (+3.11%), the Shariah-based index DSES (+2.04%), and the large-cap index CDSET (+2.90%) closed at 2,086.36, 1,239.58, and 1,169.47 points, respectively. All the large-cap sectors posted positive performance today. NBFI booked the highest gain of 4.79% followed by Telecommunication (+4.31%), Engineering (+2.99%), Fuel & Power (+2.91%), Pharmaceutical (+1.64%), Bank (+0.86%), and Food & Allied (+0.43%), respectively. Block trades contributed 17.1% of the overall market turnover. Bangladesh Export Import Company Ltd. (+9.8%) was the most traded share






