Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.23%) lost 14.7 points and closed at 6,256.17. The blue-chip index DS30 (-0.24%), the Shariah-based index DSES (-0.25%), and the large-cap index CDSET (-0.11%) closed at 2,226.66, 1,368.28, and 1,222.82 points, respectively. Largecap sectors posted mixed performance today. Engineering booked the highest gain of 0.03% followed by Bank (+0.00%), Telecommunication (0.00%). Pharmaceutical experienced the highest loss of 0.3% followed by Fuel & Power (-0.07%), NBFI (-0.05%), Food & Allied (-0.02%). Block trades contributed 9.3% of the overall market turnover. Olympic Industries Ltd. (+0.3%) was the most traded share with a turnover of BDT 313 million.




