
Market closed in red

The market closed in red today. The benchmark index DSEX (-0.34%) lost 23.97 points and closed at 7,036.77. The blue-chip index DS30 (-0.30%), the Shariah-based index DSES (+0.01%), and the large-cap index CDSET (-0.28%) closed at 2,589.26, 1,520.01, and 1,398.95 points, respectively. Most of the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 1.44% followed by Bank (-0.72%), Food & Allied (-0.68%), Telecommunication (-0.48%), Fuel & Power (-0.03%), Pharmaceutical (+0.09%), and Engineering (+2.15%), respectively. Block trades contributed 0.4% of the overall market turnover. Fortune Shoes Limited (-0.1%) was the most traded share with a turnover of BDT 2,534


