Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.18%) lost 11.15 points and closed at 6,245.02. The blue-chip index DS30 (-0.21%), the Shariah-based index DSES (-0.10%), and the large-cap index CDSET (-0.11%) closed at 2.222.02, 1,366.85, and 1,221.51 points, respectively. Most of the large-cap sectors posted negative performance today. Food & Allied experienced the highest loss of 0.20% followed by Pharmaceutical (-0.16%), Bank (-0.06%), NBFI (-0.03%), Fuel & Power (-0.02%), Telecommunication (0.00%), and Engineering (+0.10%), respectively. Block trades contributed 14.7% of the overall market turnover. Sonali Paper & Board Mills Ltd. (-0.9%) was the most traded share with a turnover of BDT 370 million.




