


Market closed in green

The market closed in green today. The benchmark index DSEX (+0.10%) gained 6.92 points and closed at 7,043.69. The bluechip index DS30 (+0.36%), the Shariah-based index DSES (+0.08%), and the large-cap index CDSET (+0.32%) closed at 2,598.61, 1,521.21, and 1,403.45 points, respectively. Large-cap sectors posted mixed performance today. Pharmaceutical booked the highest gain of 0.13% followed by NBFI (+0.07%), Fuel & Power (+0.06%). Bank experienced the highest loss of 0.53% followed by Food & Allied (-0.36%), Telecommunication (-0.16%), Engineering (0.00%). Block trades contributed 0.5% of the overall market turnover. Bangladesh Export Import Company Ltd. (+3.8%) was the most traded share with a turnover of BDT 1,373 million.



BDFINANCE

The Board of Directors has recommended 6% Cash and 6% Stock dividend for the year ended December 31, 2021. Date of AGM: 31.03.2022, Time: 11:30 AM, Venue: Digital Platform. Record Date: 09.03.2022. The Company has also reported Consolidated EPS of Tk. 1.44, Consolidated NAV per share of Tk. 17.73 and Consolidated NOCFPS of Tk. 6.58 for the year ended December 31, 2021 as against Tk. 1.69, Tk. 16.85 and Tk. 3.58, respectively for the same period of the previous year. The Company has also informed that they recommended stock dividend to increase the capital base and to support the growth of the organization. The Company has declared stock dividend out of the profit. Bonus share has not been declared from the revaluation or any unrealized gain or through reducing paid up capital so that the post dividend retained earnings will have negative impact.
