

The market closed in red today. The benchmark index DSEX (-0.43%) lost 23.71 points and closed at 5,503.68. The blue-chip index DS30 (-1.20%), the Shariah-based index DSES (-0.13%), and the large-cap index CDSET (-1.31%) closed at 2,120.40, 1,250.91, and 1,177.39 points, respectively. All the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 2.59% followed by Engineering (-1.85%), Food & Allied (-0.97%), Bank (-0.89%), Fuel & Power (-0.84%), Telecommunication (-0.52%), and Pharmaceutical (+0.39%), respectively. Block trades contributed 1.3% of the overall market turnover. Bangladesh Export Import Company Ltd. (-5.9%) was the most traded share with a turnover of BDT 2,587 million.


