
Market closed in red

The market closed in red today. The benchmark index DSEX (-0.74%) lost 52.34 points and closed at 6,991.36. The blue-chip index DS30 (-0.95%), the Shariah-based index DSES (-0.86%), and the large-cap index CDSET (-0.79%) closed at 2,573.85, 1,508.14, and 1,392.32 points, respectively. All the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 2.16% followed by Pharmaceutical (-0.97%), Fuel & Power (-0.81%), Engineering (-0.70%), Food & Allied (-0.54%), Bank (-0.50%), and Telecommunication (-0.49%), respectively. Block trades contributed 0.8% of the overall market turnover. Bangladesh Export Import Company Ltd. (+0.1%) was the most traded share with a turnover of BDT 1,049 million.


