

# **Daily Market Update**

The market closed in red today. The benchmark index DSEX (-0.50%) lost 27.69 points and closed at 5,475.99. The blue-chip index DS30 (-0.70%), the Shariah-based index DSES (-0.67%), and the large-cap index CDSET (-0.68%) closed at 2,105.58, 1,242.49, and 1,169.33 points, respectively. All the large-cap sectors posted negative performance today except Fuel & Power (+0.04%), and Engineering (+2.31%). Telecommunication experienced the highest loss of 4.43% followed by Pharmaceutical (-0.61%), Food & Allied (-0.51%), Bank (-0.34%), and NBFI (-0.17%), respectively. Block trades contributed 1.5% of the overall market turnover. Bangladesh Export Import Company Ltd. (+1.6%) was the most traded share with a turnover of BDT 2,132 million.



## BATBC

The company has informed that Board of Directors of the company has approved the investments decision amounting BDT 192.50 crore (One hundred ninety-two crore fifty lac) to increase the manufacturing capacity in Savar factory to enhance the upcoming export opportunities of cigarettes from Bangladesh. The investment will be funded from internal financing.
