
## **Daily Market Update**

## **DSEX Index Closing 5,385.65** ↑ (+67.93, +1.28%)

Market closed in green

The market closed in green today. The benchmark index DSEX (+1.28%) gained 67.93 points and closed at 5,385.65. The blue-chip index DS30 (+1.93%), the Shariah-based index DSES (+1.16%), and the large-cap index CDSET (+1.75%) closed at 2,056.37, 1,220.69, and 1,146.00 points, respectively. All the large-cap sectors posted positive performance today. Engineering booked the highest gain of 3.47% followed by Telecommunication (+3.13%), NBFI (+2.02%), Pharmaceutical (+1.75%), Fuel & Power (+0.80%), Bank (+0.18%), and Food & Allied (+0.14%), respectively. Block trades contributed 3.5% of the overall market turnover. Bangladesh Export Import Company Ltd. (+5.9%) was the most traded share with a turnover of BDT 1,241 million.




