

# **Daily Market Update**

The market closed in green today. The benchmark index DSEX (+0.26%) gained 16.44 points and closed at 6,301.70. The blue-chip index DS30 (+0.47%), the Shariah-based index DSES (+0.32%), and the large-cap index CDSET (+0.13%) closed at 2,117.91, 1,375.92, and 1,209.13 points, respectively. Large-cap sectors posted mixed performance today. Pharmaceutical booked the highest gain of 0.17%, followed by Food & Allied (+0.05%), Bank (+0.04%), Fuel & Power (+0.01%), Telecommunication (+0.00%), Engineering (-0.01%), and NBFI (-0.17%), respectively. Block trades contributed 7.0% of the overall market turnover. Deshbandhu Polymer Limited (+8.0%) was the most traded share with a turnover of BDT 331 million.


