### **Daily Market Update**

Market closed in green

The market closed in green today. The benchmark index DSEX (+0.87%) gained 52.99 points and closed at 6,150.22. The bluechip index DS30 (+0.37%), the Shariah-based index DSES (+0.94%), and the large-cap index CDSET (+0.73%) closed at 2,111.09, 1,354.39, and 1,181.23 points, respectively. All the large-cap sectors posted positive performance today. Engineering booked the highest gain of 5.43% followed by NBFI (+2.21%), Fuel & Power (+1.95%), Pharmaceutical (+0.92%), Bank (+0.53%), Telecommunication (+0.16%), and Food & Allied (-0.03%), respectively. Block trades contributed 2.7% of the overall market turnover. Bd.Thai Aluminium Ltd. (-4.1%) was the most traded share with a turnover of BDT 441 million.




