Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.28%) lost 17.49 points and closed at 6,177.88. The blue-chip index DS30 (-0.10%), the Shariah-based index DSES (-0.34%), and the large-cap index CDSET (-0.07%) closed at 2,191.43, 1,351.02, and 1,213.32 points, respectively. Most of the largecap sectors posted negative performance Pharmaceutical experienced the highest loss of 0.41% followed by Food & Allied (-0.15%), Engineering (-0.14%), Fuel & Power (-0.06%), NBFI (-0.01%), Telecommunication (0.00%), and Bank (+0.05%), respectively. Block trades contributed 18.5% of the overall market turnover. Orion Pharma Ltd. (-1.6%) was the most traded share with a turnover of BDT 99 million.




