
# Market closed in red

The market closed in red today. The benchmark index DSEX (-0.78%) lost 54.84 points and closed at 6,932.61. The blue-chip index DS30 (-0.92%), the Shariah-based index DSES (-0.27%), and the large-cap index CDSET (-0.67%) closed at 2,579.12, 1,468.14, and 1,386.07 points, respectively. All the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 1.50% followed by Telecommunication (-0.98%), Bank (-0.96%), Food & Allied (-0.53%), Fuel & Power (-0.49%), Engineering (-0.35%), and Pharmaceutical (-0.34%), respectively. Block trades contributed 0.5% of the overall market turnover. Bangladesh Export Import Company Ltd. (-1.9%) was the most traded share with a turnover of BDT 1,047 million.




