


BRAC EPL STOCK BROKERAGE LTD Daily Market Update

Market closed in green

The market closed in green today. The benchmark index DSEX (+0.22%) gained 12.28 points and closed at 5,634.05. The blue-chip index DS30 (+0.93%), the Shariah-based index DSES (+0.63%), and the large-cap index CDSET (+0.91%) closed at 2,067.19, 1,273.92, and 1,185.51 points, respectively. Large-cap sectors posted mixed performance today. Telecommunication booked the highest gain of 4.21% followed by NBFI (+3.33%), Food & Allied (+1.06%), and Pharmaceutical (+0.61%). Engineering experienced the highest loss of 1.05% followed by Bank (-0.85%) and Fuel & Power (-0.46%). Block trades contributed 1.9% of the overall market turnover. Bangladesh Export Import Company Ltd. (+0.6%) was the most traded share with a turnover of BDT 1,220 million.


